### How to leave your legacy Gift in your Will

Having a will and keeping it up-to-date helps ensure that your property and assets benefit people and causes you personally care about - it also gives you peace of mind that your wishes will be followed.

We would always recommend that you speak to a qualified professional, such as a solicitor, when making or amending your will.

A solicitor will be able to advise you on the required wording to carry out your wishes. If you wish to leave a gift to MVA in your will, all you need is our charity details below:

If you already have a will and you want to include a MVA in it, there may not be a need to rewrite it. You can ask your solicitor to add an amendment (called a codicil). In general, if the change you wish to make is quite small or simple you can use a codicil, but if the change is more significant or complex you may need to make a new will.

If you have remembered MVA in your Will, we'd love to hear from you. Not only will this help us make plans for the future of MVA, it also means we can thank you properly for your support. Anything you tell us will be confidential and not legally binding.
